Conservation Incentive Program

General Instructions

Benton SWCD Conservation Incentive Program, funded through local property taxes is available to help Benton County residents install conservation practices on their land. Project types are listed below. The program's primary goals are to protect and maintain water and soil quality. Completion of this application indicates that the landowner or lessee is agreeable to receiving technical assistance on the proposed project and follow specifications set forth by the Benton SWCD.

- The maximum payment awarded to a successful grant application is \$3,000. Benton SWCD would pay 50% of the project cost, up to \$3,000. Applicants are required to provide 50% of the project funds, which can be provided as labor costs, materials, cash, or financial assistance from other sources. If the application is requesting technical assistance funds, then the District would pay up to 75% of technical assistance costs and applicant pays 25% of requested funds.
- Equipment that is critically needed for the life of the conservation practice may be included in the project budget. (Please contact the Benton SWCD to verify equipment need.)
- Consultation fees and overhead costs will not be reimbursed by grant funding.
- A maximum of one grant may be awarded per landowner per District Fiscal year (July 1st to June 30th).

Incomplete applications will not be processed.

Permanent erosion control (filterstrips, field borders, grassed waterways)	Fencing to exclude livestock from surface water
Noxious/invasive weed removal associated with native plant restoration	Cover crops
Pasture management (cross-fencing, reseeding, grazing mgmt)	Forestry practices
Temporary erosion control (silt fences, straw wattles, etc.)	Heavy use area protection
Watering facilities away from sensitive areas for livestock	Vegetation management for desired species
Technical assistance to assure project implementation	Wildlife habitat enhancement/restoration
